## **Christian unity?**

Oh dear. The shame of it. At the very start of the Week of Prayer for Christian Unity (annually from the  $18^{th} - 25^{th}$  January), an attempted vote of no confidence in the chairman House of Laity of the General Synod of the Church of England by its members in the wake of the vote on women bishops. It succeeded only (the motion itself being defeated) in parading before an increasingly bemused nation the divisions and disagreements of the National Church over direction of travel and fundamental order. This at precisely the same moment as, in the background, the formal steps are taken to confirm the appointment of our new Archbishop of Canterbury, Justin Welby. What a burden it must be to be an 'instrument of unity' in such times as these.

Church life is highly politicised. On the one hand this is a good thing because it points to the fact that people care, often passionately, about fundamental things in the church's life (how much worse, after all, for there to be simply a sea of apathy and for nothing to matter very much!). But passionate debate and disagreement feels to many to be very much at odds with the Church's supposed message of peace and unity – and this perceived dissonance is the more acute in a week set aside for praying for unity within the Body of Christ.

Whither unity? As is so often the case, a little theological reflection is helpful. Christians contend that the unity we seek comes not from our own strivings and skilled politicking. If this were the case, there would be no hope – for however politically adept we are (and it has to be confessed that we have not, as a National Church, demonstrated much political acumen in recent months!) we will never be so skilled that we manage agreement continuously. Actually it is rather a good thing to have disagreement and debate – as a sign of life and of growth and of curiosity. Rather Christians believe that our unity flows from God – and not as a distant ideal, but as an already-experience reality; it comes from our Baptism in which we are made one within the Body of Christ by God. This means that, though we may disagree, the manner in which we must do so is prescribed – not, of course, in terms of procedure (sadly neither Scripture nor tradition guite lay down the way in which Christians should conduct debate and achieve clarity about what to do!), but certainly in terms of fundamental attitude. All our debating, our reflecting, our disagreeing starts with the non-negotiable fact that we are (and must be) together, and that conviction must inform the tone and manner of our debating. The scandal of recent weeks is not the debate itself – but the shrill, unkind, judging way in which so much of it has been conducted. And for Christians, of course, this principle holds true for national debate and for those more domestic or in-house debates and disagreements we have as congregations or families.

We pray, O Lord, for the Church which is one in the greatness of your love, but divided by the littleness of our own. May we be less occupied with the things that divide us, and more with those we hold in common, and the love that enfolds us all, in Jesus Christ our Lord. Amen.

#### **PCC MEETING**

At its meeting on Monday 14<sup>th</sup> January 2013, the Parochial Church Council dealt with a number of administrative matters - including the question of how its deliberations might better be communicated to the wider congregation. It was agreed that as a parish we should continue to move towards the creation of a congregation-specific (log-in) web-portal so that all members might have access to all relevant documents that are in the public domain, including minutes – and that until then the minutes of meetings (once approved) continue to be available to all members of the Electoral Roll on request from the Parish Office. In any case, the PCC makes an annual report on the life and proceedings of the Parish to the Annual Parochial Church Meeting – and a summary of points debated might appear in the Weekly Sheet. On Monday the PCC discussed admintrative matters including the necessary extension of the Lease on the flats above the Hall in Kinnerton Street, Insurance, Tree works, December use of the Church

by Charitable bodies and our own December programme, and noted forthcoming events. There was substantive discussion of progress on the agenda set at the PCC Away Day in October 2012, including the Database, development of earlymorning meditation sessions during the week, and the Volunteering Programme being developed by Roland Brunner.


